In compliance with the requirements of F.S. Chapter 607 ALLES SEE FLORIDA undersigned, RICHARD LORENZ, being a natural person, does hereby act as an Incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business Corporation.

ARTICLE I


