September 1, 2004

Way back in April of 2004, we paid the \$150 re-filing fee. The check was cashed and I thought everything was fine. Our mailing address had changed to a new P.O. Box and I notified the division of corporations, yet I feel that the change was not made promptly enough to ensure I was getting any mail from you. Furthermore, when the address change was actually done, I was still unable to receive mail from you because someone at your department had written the wrong P.O. Box for us. <sup>They wrote the wrong P.O. Box.</sup> So we did not get any mail.
