**ARTICLE OF INCORPORATION**  
**A-I FOOD MART OF OCALA INC.**

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act hereby adopt the following Articles of Incorporation:

**ARTICLE ONE**

The name of the Corporation is **A-I Food Mart of Ocala INC.**

**ARTICLE TWO**

The corporation shall have perpetual existence. The date and time of the commencement corporation existence is at the time of filing the Articles of Incorporation by the Department of State.

**ARTICLE THREE**

The general purpose for which the corporation is organized are:

1. To engage in the business of retail sale of food and other commodities
2. To engage in any and all lawful business activity permitted under the laws of the United States and or the State of Florida, including, but not by way of limitation, the lending and borrowing of money, with or without security therefore.
3. To make and enter into all contracts necessary and proper for the conduct of its business and businesses.
4. To do any and all things necessary, suitable and proper for the accomplishment of any of the purposes, or for the attainment of any of the objects, or for the exercise of any of the powers herein set forth, whether herein specified or not, either along or in connection with other firms, individuals or corporations, whether in the State of Florida or throughout the United States or elsewhere, and to do any other act or acts, thing or things, incidental or pertinent to, or connected with the businesses hereinbefore described, or any part or parts thereof if not inconsistent with laws of the State of Florida.
5. In general, this corporation shall have and exercise all the powers conferred by the Laws of the State of Florida upon corporations for profit. It is hereby expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner such general powers.

**ARTICLE FOUR**

This Corporation is authorized to issue 1,000 shares of common stock with a par value of \$1.00 per share.

#### **ARTICLE FIVE**

The street address of the initial registered office of the corporation is 149 SW Martin Luther King Blvd, Ocala, Florida and the name of its initial registered agent at such address is Hisham Abu Daher.

#### **ARTICLE SIX**

The number of directors constituting the initial board of directors of the corporation is one (1). The name and address of each person who is to serve as member of the initial board of directors is:

## ARTICLE TEN

The Corporation may be dissolved at any time (1) by unanimous written consent of the shareholders of (2) on the affirmative vote of the holders of at least two-thirds (2/3) of the outstanding shares of the corporation entitled to vote their own. On Dissolution the corporation property and assets shall, after payment of all debts of the corporation, be distributed to the shareholders pro rata, each shareholder to participate in the distribution in direct proportion to the number of shares held by him.

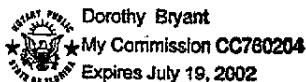
