ARTICLES OF INCORPORATION

## PURPOSES OF PROFESSIONAL SERVICES CORPORATION

This corporation is organized for the following purposes:

- a. To engage in the practices of law as a professional law corporation and to carry on services incident to the practice of law. The practice to law is the sole and exclusive professional service to be rendered by this corporation.
- b. To own property, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation.
