

ARTICLES OF DISSOLUTION

Pursuant to §607.1402 and §607.1403 of the Florida Business Corporation, Act (the & "FBCA"), USMG ACQUISITION CORP., a Florida corporation (the "Corporation"), submits and files these Articles of Dissolution with the Florida Department of State and provides the following information:

- (1) ARTICLE FIRST: The name of the Corporation is **USMG Acquisition Corp.**
- (2) ARTICLE SECOND: The date of authorization of the dissolution of the Corporation pursuant to the FBCA was October 30, 2002.
- (3) ARTICLE THIRD: The complete dissolution and liquidation of the Corporation was duly adopted and approved by unanimous written consent of all of the shareholders and all of the members of the Board of Directors of the Corporation pursuant to §607.1402, §607.0704, and §607.0821 of the Florida Business Corporation Act on October 30, 2002. Such votes were sufficient for approval under the FBCA.
- (4) ARTICLE FOURTH: The effective date of the dissolution of the Corporation shall be the date of filing of these Articles of Dissolution with the Department of State of Florida.
