ARTICLES OF INCORPORATION

OF

LARSEN POOL & PATIO, INC.

The undersigned, acting as Incorporator pursuant to Chapter 607 of the Florida Statutes, adopts the following Articles of Incorporation.

ARTICLE I. NAME
