

ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming and organizing a corporation for profit under the provisions of the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is VENICE RESTAURANT, INC.

<u> ARTICLE II - PURPOSE</u>

The corporation is authorized to conduct any activity or business permitted under the laws United States and of the State of Florida.
