# ARTICLES OF INCORPORATION OF

#### ARTICLE I-Name

The name of this corporation is Countywide Affiliated Agents, Inc.

#### ARTICLE II- Principal Office

The address of the principal office and mailing address is 227 North Ridgewood Drive, Sebring, Florida 33870.

#### ARTICLE III-Duration

This corporation shall have perpetual existence.

#### ARTICLE IV-Purpose

This corporation is organized for the purpose of transacting any or all lawful business.
