BY THESE ARTICLES OF INCORPORATION the incorporator forms a corporation for profit under Florida law.

1. **NAME** The name of this Corporation is:

3. **TERM** This Corporation shall exist perpetually.

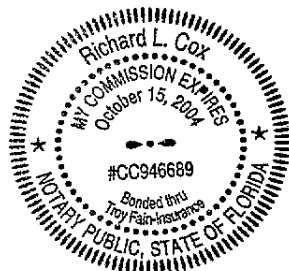
