Articles of Incorporation

SECRETARY OF STATE

The undersigned incorporator, for the purpose of forming a corporation under the Florida Corporation Act, hereby adopts the following articles of incorporation.

Article 1 - Name

The name of the corporation shall be

Kendal Homes, Inc.

Article 2 - Duration

The duration of the corporation is perpetual.

Article 3 - Principal Office and Mailing Address

The principal office and mailing address shall be 985 Knollwood Drive, Dunedin, Florida 34698.

Article 4 - Shares

The number of shares of stock that is authorized to have outstanding at any one time is 5,000 shares of common stock with par value of \$10.00 per share, divided into two classes of common stock: voting and non-voting.

Article 5 – Initial Registered Agent and Street Address

Having been named as registered agent and to accept service of process for the corporation at the place designated, I hereby accept appointment and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent.

Article 6 - Liability of Directors
