ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

ARTICLE I - NAME

Section 1.1 Name. The name of the corporation is Key Automated Medical Systems, Inc.

ARTICLE II - INITIAL PRINCIPAL OFFICE AND MAILING ADDRESS

Section 2.1 <u>Initial Principal Office and Mailing Address</u>. The initial principal office address is 670 Kingsley Avenue, Orange Park, FL 32073. The mailing address is 669 Kingsley Avenue, Orange Park, FL 32073.
