ARTICLE I

NAME

The name of this corporation is "Fouraker Management Company"

ARTICLE II

NATURE OF BUSINESS

EFFECTIVE DATE

This corporation is organized for the purpose of real property management and engaging in and transacting any or all lawful business permitted under the laws of the State of Florida or any other state and of the United States.

ARTICLE III

CAPITAL STOCK

This corporation is authorized to issue Ten Thousand (10,000) shares of common stock having a par value (\$.01) per share, which shares shall be and hereby are designated as "Common Shares". 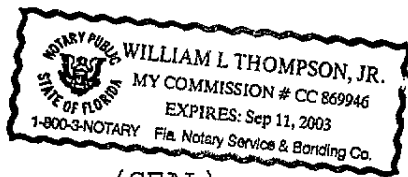
