## ARTICLES OF INCORPORATION OF MATTHEW R. MERRITT, INC.

Ol College War The The undersigned subscribers to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida, effective November 1, 2001.

### ARTICLE I

The name of this corporation is MATTHEW R. MERRITT, INC.

#### ARTICLE II

The general nature of this business to be transacted by this corporation is management, consulting, all related EFFECTIVE DATE services, and:
