**NAME**

The name of this corporation is: Keystone Financial Services Corp.

**ARTICLE II**  
**PURPOSE**

To engage in any activity or business permitted under the laws of the United States and the State of Florida.

**ARTICLE III**  
**CAPITAL STOCK**


**ARTICLE VIII



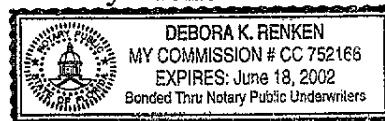


