

NAME AND ADDRESS OF PRINCIPAL OFFICE

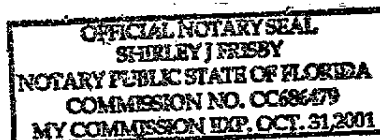
