ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

Corporate Name. The name of the corporation is PROPERTY ARTICLE I: MANAGEMENT TEAM OF NORTH FLORIDA, INC.

The corporation shall exist in perpetuity Corporate Existence. ARTICLE II: commencing as of the execution of these Articles.

Corporate Purpose. This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.

ARTICLE XII: Indemnification. Directors and officers of this Corporation shall be indemnified to the fullest extent permitted by law.
