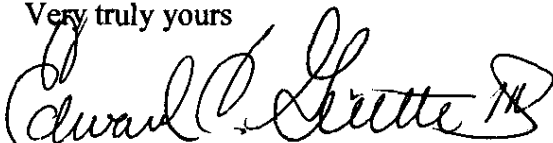
This corporation did not receive any prior notification of the requirement to file the subject report. Although organized in 2001 this corporation did no business until CY 2003. It is just now really organized to start.
