ARTICLES OF INCORPORATION EFFECTIVE DATE OF COASTAL CABINET REFACING, INC. 10 20 0 E E D

The undersigned, acting as incorporator of a corporate profit of the Florida General Corporation Act, adopts the Florida General Corporation Act, adopts the Florida Florida General Corporation for such corporation.

ARTICLE I.

NAME: The name of this corporation is COASTAL CABINET

REFACING, INC. and the principal place of business shall be 5839

Pinecrest Road, Crestview, FL 32539.

ARTICLE II.

<u>DURATION</u>: The corporation shall exist perpetually.

ARTICLE III.
