ARTICLES OF INCORPORATION
OF

In compliance with chapter 607 and/or chapter 621, F.S. (profit), the undersigned, for the purpose of forming a Florida corporation, hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be: Woertendyke Surveying, Inc.

ARTICLE II

The principal place of business/ mailing address is:

The purpose for which the corporation is organized is to provide Surveying services and any other lawful business for profit.
