ARTICLES OF INCORPORATION 01 OCT 29 AM 11:04

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of this corporation is Flex-Flow, Inc. The principal place of business is 24 West Chase Street, Pensacola, Florida 32501.

ARTICLE II

DURATION

The duration of this corporation is perpetual.

ARTICLE III

PURPOSE

The general purposes for which this corporation is organized are:

- (1) To transact any lawful business or businesses for which corporations may be incorporated under the Florida General Corporation Act.
- (2) To do such other things as are incidental to the foregoing or necessary, implied, helpful, or desirable in order to accomplish the foregoing.

ARTICLE IV**CAPITAL STOCK**

This corporation is authorized to issue two classes of stock as follows:

Class A Common. This corporation is authorized to issue 10,000 shares of voting common stock of no par value per share which shall be designated as "Class A Common".

Class B Common. This corporation is authorized to issue 10,000 shares of non-voting common stock of no par value per share, which shall be designated as "Class B Common".

The sole distinction between Class A Common and Class B Common is that holders of Class B Common have no voting rights while holders of Class A Common have voting rights as are afforded by law to holders of common stock.

ARTICLE V**REGISTERED OFFICE AND AGENT**

The street address of the initial registered office, and the mailing address of the Corporation in this State is 24 West Chase Street, Pensacola, Florida 32501, and the name of its initial registered agent at such address is Daniel R. Lozier.

ARTICLE VI**BOARD OF DIRECTORS**

The initial Board of Directors of this corporation shall consist of three (3) members. The size of the board may be increased or decreased from time to time as prescribed in the bylaws or by applicable law, but never shall the board consist of less than one (1) member. 


