The undersigned incorporator competent to contract and licensed to operate a retail collection agency in the State of Florida, hereby forms a business corporation in accordance with the FLORIDA BUSINESS SERVICE CORPORATION ACT, and hereby adopts the following articles of incorporation:

ARTICLE I - NAME

The name of the CORPORATION is BLUESTONE, ADAM & CROSS, INC..

ARTICLE II - PURPOSE

The corporation is organized for the following purposes:

- A. To engage in the service of providing collection services incident thereto. This service of collections and related services is the sole and exclusive business service to be rendered by this corporation.
- B. To own property, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objectives of the corporation.
- C. The business services of this corporation shall be carried out only through officers, employees and agents, each of whom has been duly authorized to act as agents of collection in the state of Florida.

### ARTICLE III - CAPITAL STOCK

The total number of shares of capital stock which the corporation shall be authorized to issue is 100 shares. The shares of stock authorized shall be common stock having a par value of \$10.00 per share.

### ARTICLE IV - CAPITALIZATION

The Amount of capital with which the CORPORATION will begin is \$1,000.00

### ARTICLE V - BEGINNING OF CORPORATE EXISTENCE

The date when existence of this CORPORATION shall begin business shall be October 17, 2001.

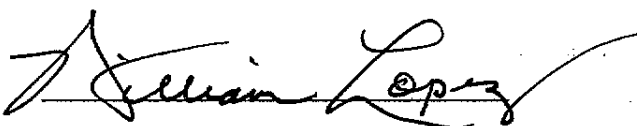
