

**ARTICLE III**


**CAPITAL**





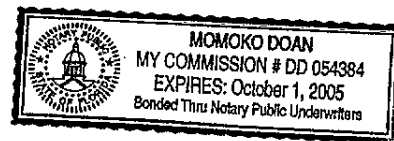
