ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a Corporation under the Florida Business Corporations Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I - Name

The name of this Corporation is JORDAN INVESTMENT GROUP, INC. The principal place of business of this Corporation shall be 30942 Iverson Drive, Wesley Chapel, Florida 33543 or such other place as may be designated by the Board of Directors.

Article II - Capital Stock
