ARTICLE I - NAME

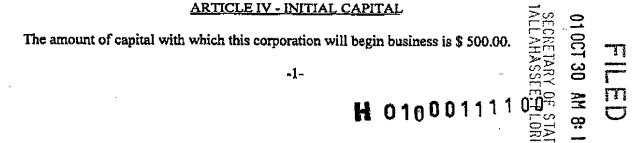
The name of this corporation is Vinko, Inc. and the mailing and principal address is 5790 SW 130th Terrace, Miami, Florida 33156.
