The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

**ARTICLE I**  
**NAME**

The name of the corporation is:

The principal place of business of this corporation shall be 313 Dirkson Dr. #A6, DeBary, FL 32713.

**ARTICLE II**  
**DURATION**

The duration of the corporation is perpetual.

**ARTICLE III**  
**NATURE OF BUSINESS**

This corporation may engage in or transact any of all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

**ARTICLE IV**  
**CAPITAL STOCK**

The aggregate number of shares which the corporation is authorized to issue is 100 shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

The corporation shall indemnify any officer or director or any former officer or director, to the full extent permitted by law.


**ARTICLE X




