ARTICLES OF INCORPORATION
OF

SOUTHLAND FOREST PRODUCTS OF SUWANNEE COUNTY, INC. SECRETARY OF STATE
TALLAHASSEE, FLORIDA

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is SOUTHLAND FOREST PRODUCTS OF SUWANNEE COUNTY, INC.

ARTICLE II

The existence of the Corporation shall begin upon the filing of these Articles of Incorporation.

ARTICLE III

The street address of the principal office of the Corporation is 18712 128th Street, Live Oak, Florida 32060.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 1,000, par value \$1.00 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE V

The holders of the common stock of this corporation shall have preemptive rights to purchase, at prices, terms and conditions that shall be fixed by the Board of Directors, such of the shares of the stock of this corporation as may be issued for money, or any property or services, from time to time, in addition to that stock authorized and issued by the corporation. The preemptive right of any holder is determined by the ratio of the authorized and issued shares of common stock held by the holder of all shares of common stock currently authorized and issued.

ARTICLE VI

The initial street address of the Corporation's registered office is 18712 128th Street, Live Oak, Florida 32060, and its mailing address is 18712 128th Street, Live Oak, Florida 32060. The initial registered agent for the Corporation at that address is CLIFFORD W. STARLING.

ARTICLE VII

The initial board of directors shall consist of one member, who shall serve as director until the first annual meeting of shareholders, or until their successors shall have been elected and qualified. This number may be increased or decreased from time to time in accordance with the Corporation's bylaws, but shall never be less than one. 
