**ARTICLE V: OFFICERS/DIRECTORS:**

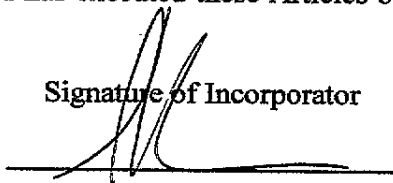

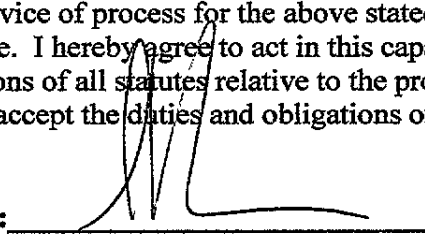
