ARTICLES OF INCORPORATION FOR BADE SERVICES GROUP, INC.

I, the undersigned, make, subscribe, acknowledge and file vitted with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation in accordance with the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be:

BADE SERVICES GROUP, INC.

ARTICLE II

The purpose of the corporation shall be to conduct any business and to engage in any activity that would be lawful under the laws of the State of Florida and the United States of America, whether for profit or otherwise.

ARTICLE III
