**ARTICLES OF INCORPORATION
OF
WHITEMARK/NFC ACQUISITION CORPORATION**

The undersigned, acting as Incorporator, desiring to form a corporation for profit pursuant to the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I-NAME

The name of this corporation is Whitemark/NFC Acquisition Corporation.

ARTICLE II-ADDRESS OF PRINCIPAL OFFICE
