
ARTICLE I - NAME

The name of the corporation is: UK WEB WORKS, INC.

ARTICLE II - DURATION

The corporation shall have perpetual existence.

ARTICLE III - PURPOSE



- B. To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness.
