ARTICLE I. NAME

The name of this corporation is Right On Time Couriers, Inc.

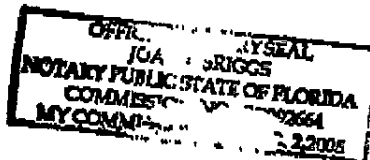

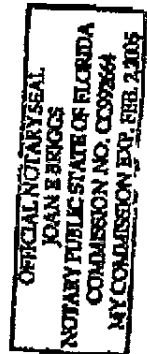
