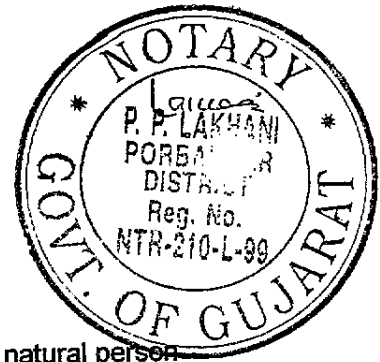

**ARTICLES OF INCORPORATION OF
ARTI GENERAL TRADING, INC.**



The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby binds himself to form a corporation under the laws of the State of Florida.

1. **ARTICLE I Name.**

The name of the corporation shall be:

2. **ARTICLE II PRINCIPAL OFFICE**

3. **ARTICLE III PURPOSE**

4. **ARTICLE IV TERM**

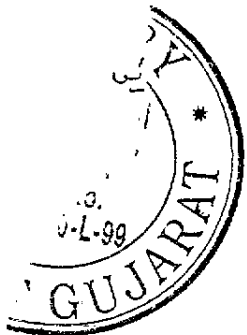
This corporation shall have perpetual existence.

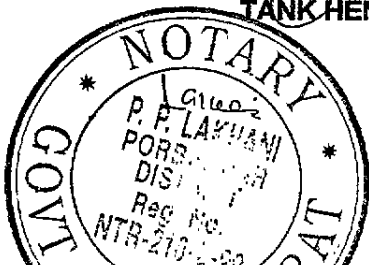

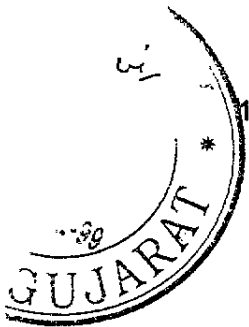

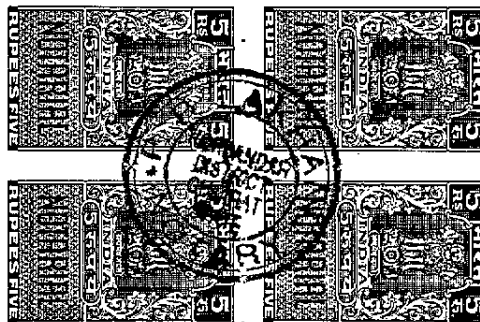
