ARTICLE THREE SHARES

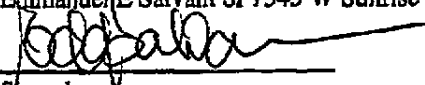

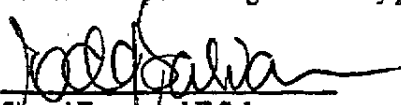
