# ARTICLES OF INCORPORATION OF KEITH LAWSON SERVICES, INC.



The undersigned Incorporator hereby files these Articles of Incorporation in order to form a Corporation under the laws of the State of Florida.

# Article 1. Name and Principal Office

The name of this Corporation shall be **KEITH LAWSON SERVICES**, **INC**. The principal place of business and mailing address of this Corporation shall be 2481 Luten Road, Quincy, Florida 32351.

## Article 2. Nature of Business

The Corporation may engage in any activity or business permitted under the laws of the United States of America and the State of Florida.
