
ARTICLE VIII

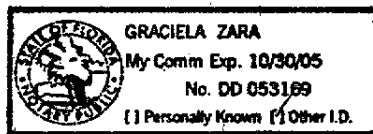


