I, ABBAS A. SADRIWALLA, being of legal age, do hereby sign these presents for the purpose of becoming a Corporation under the laws of the State of Florida authorizing the formation of Corporation. These Articles of Incorporation are to be effective on the October 29, 2001 (If no date is inserted, these Articles are to be effective as of the date of filing with the Secretary of State).

ARTICLE I
