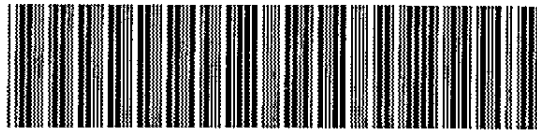

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The present name of the corporation is **JAR/LIN ELECTRIC, INC.** (the "Corporation").

2. The Articles of Incorporation of the Corporation are hereby amended to read as follows:

The name of this corporation shall be changed to "**KER/LIN ELECTRICAL CONSTRUCTION, INC.**"

3. This Amendment was recommended by the board of directors to the Corporation's shareholders on December 16, 2002 at a Special Meeting of the directors and shareholders.

4. This Amendment was unanimously approved by the Corporation's common stockholders, which are the only group of the Corporation's shareholders entitled to vote on the Amendment, the number of votes in favor of the Amendment was sufficient for approval.

5. In all other respects the Articles of Incorporation of the Corporation shall remain as published, including all previous amendments.
