ARTICLES OF INCORPORATION

OF

ARTICLE I

NAME

The name of this corporation is: ALL ABOUT CHILDREN, INC.

ARTICLE II

DURATION

The term of existence of the corporation is perpetual.

ARTICLE III

PURPOSE
