

ARTICLE X - AMENDMENT

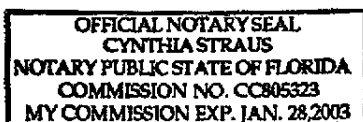
