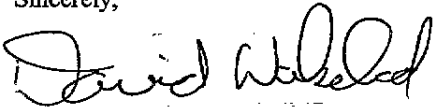

The undersigned subscriber, Andy Schwartz , competent to contract for the purpose of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation:

ARTICLE I

The name of the proposed corporation is: County Rescue, Towing & Salvage, Inc.

ARTICLE II

The corporation may engage in any activity or business permitted under the laws of the United State of America and the state of Florida.

ARTICLE III

The total number of shares of stock which the corporation shall have authority to issue is 100,000 shares at a par value of \$1.00 per share.

ARTICLE IV

The amount of capital which the corporation shall begin business is \$1000.

ARTICLE V

The corporation shall have perpetual existence.

ARTICLE VI

The principal place of business of this corporation shall be located at 1061 Inlet Drive, Marco Island , Florida, 34145. The corporation may have such other places of business within and without the State of Florida, or in foreign countries as may be necessary or convenient, as may be determined by the stockholders of the corporation.

ARTICLE XI

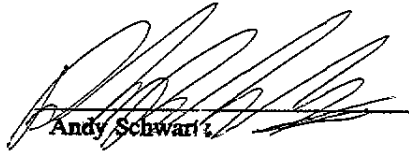
