#### ARTICLES OF INCORPORATION

OF

SECHON S AMILES The undersigned incorporator to these Articles of Incorporation hereby forms a corporation under the laws of the State of Florida as follows:

## ARTICLE I Name and Address

EFFECTIVE DATE 11-01-01

The name of the Corporation is: QUALITY OPTIONS, INC. The mailing and street address of the Corporation is: 110-B Lithia Pinecrest Road, Brandon, Florida 33511.

## ARTICLE II Term of Existence

The existence of this Corporation shall commence effective as of November 1, 2001, and shall thereafter be perpetual.

## ARTICLE III Purpose

This Corporation is organized for the purpose of transacting any and all lawful business.
