THE UNDERSIGNED, acting as sole incorporator of KeMi Enterprises, Inc. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name

The name of the corporation shall be KeMi Enterprises, Inc.


