**ARTICLES OF INCORPORATION
OF
PRESTIGE CONSTRUCTION CONSULTANTS, INC.**

The undersigned, for the purpose of forming a corporation, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is Prestige Construction Consultants, Inc., and its address is 27-31 S.E. 24th Avenue Suite #8, Pompano Beach, Florida 33062.

ARTICLE II

DURATION

The duration of the corporation is perpetual.

ARTICLE III

PURPOSES

The general purposes for which the corporation is organized are:

- (1) To transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.
- (2) To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.




