

**ARTICLES OF INCORPORATION
OF
A & G ASSOCIATES, INC.**

(a Florida corporation)

ARTICLE I



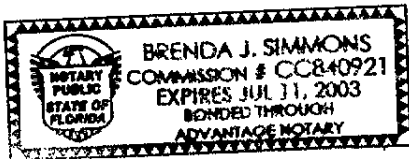
