

ARTICLES OF INCORPORATION

OF

Tikcuf Investments, Inc.

ARTICLE I NAME

The name of this corporation is Tikcuf Investments, Inc.

ARTICLE II PURPOSE

To engage in any activity or business permitted under the laws of the United States and the State of Florida.
