I, the undersigned, is desirous of forming a corporation under the laws of the State of Florida, such laws that are applicable to corporation for profit, and respectfully petition the Secretary of State for approval of such incorporation under the following proposed Certificate of incorporation.

ARTICLE 1 NAME

The name of this corporation shall be **TOTAL IMAGE MAINTENANCE SERVICE**, **INC**., and its principal place of business shall be 740 NW 177 Terrace, Miami, Florida 33169, and any other location that the Board of Directors may deem appropriate.

ARTICLE II

This corporation is to have perpetual existence, commencing upon the approval by the Secretary of State of this Certificate of Incorporation.

ARTICLE II GENERAL NATURE OF BUSINESS

The general nature of the business and object and purposes to be transacted and carried on by this corporation are to do any and all of the things herein mentioned, as fully and to the same extent as natural persons might do, viz.:

- (1) Transact any and all lawful business.
- (2) Said corporation shall further have powers to:
- (a) To have perpetual succession by its corporate name, to sue and be sued, complain, and defend in its corporate name in all actions or proceedings.
- (b) To have a corporate seal, which may be alerted at pleasure, and use by causing it, or a facsimile thereof, to be impressed, affixed, or in any other manner reproduced.
- (c) To purchase, take, receive lease, or otherwise acquire, own hold, improve, use, and otherwise deal in and with real or personal property or any interest therein, wherever situated.
- (d) To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, transfer, and otherwise dispose of all or any part of its property and assets.
- (e) To purchase, take receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with shares or other interests in or obligations of other domestic or foreign corporations, association, partnership, or individuals, or direct or indirect obligations of the United states or any other government, state, territory, governmental district, or municipality or of any instrumentality thereof.
- (g) To make contacts and guarantees and incur liabilities, borrow money at such rate of interest as the corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchise and income.

(h) To lend money for its corporate purposes, invest and reinvest its funds, and take and hold real personal property as security of the payment of funds so loaned or invest.

(i) To conduct its business, carry on its operations, and have offices and exercise the powers granted by this act within stated.

- (j) To elect or appoint officers and agents of the corporation and define their duties and fix their compensation.
- (k) To Make and alter by-laws, not inconsistent with its Article of Incorporation or with the laws of this state.
- (I) To make donations or the public welfare or for charitable, scientific, or educational purposes.
- (m) To pay pensions and establish pension plan, profit sharing plans, stock bonus plans, stock options plans, and other incentive plans for any or all of its directors, officers, and employees and for any or all of the directors, officers and employees of its subsidiaries.
- (n) To be a promoter, incorporator, partner, member, associates, or manager of any corporation, partnership, joint venture, trust, or other enterprise.
- (o) To have and exercise all powers necessary of convenient to affect its purposes.
- (p) To indemnify any person who by reason of the fact that they were a director, officer, employee or agent of the corporation to the full extent as permitted by Florida Status 607.014.

ARTICLE IV SHARES OF STOCK-NUMBERS

The maximum number of shares of stock that the corporation is authorized to have outstanding at any time is One Thousand Shares (1000) of common stock of the per value of \$.01 per share. The share shall carry no preemptive rights.
