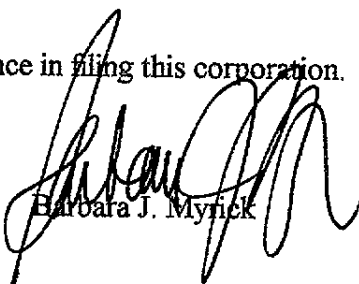

ARTICLES OF INCORPORATION

I, the undersigned incorporator, an attorney duly licensed to render professional services as such in the State of Florida, hereby make, subscribe, acknowledge and file with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a professional service corporation for profit in accordance with the laws of the State of Florida.

ARTICLE I: NAME

The name of the corporation is Barbara J. Myrick, P.A.

ARTICLE II: PRINCIPAL OFFICE & MAILING ADDRESS

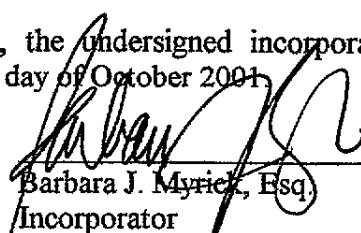

The corporation reserves the right to amend, alter, change or repeal any provision contained in these Articles of Incorporation in a manner now or hereafter prescribed by statute.

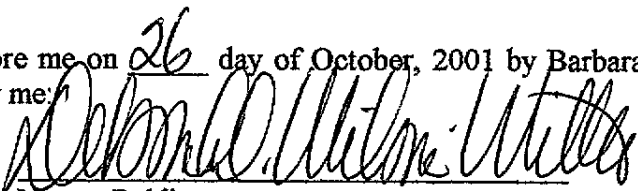

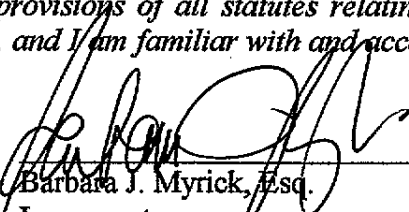
