Article I

Name and Address

The name of this corporation is Tek-Concepts, Inc. The principal address of the corporation shall be located at 310 W. Central Parkway, Suite 7500, Altamonte Springs, Florida, 32714.

Article II

Duration

The period of its duration is perpetual.

Article III

Purpose

The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.

Article IV

Capital Stock

The Corporation is authorized to issue 1,000 shares, all of one class, with a .01 par value.

Article V

Initial Registered Office and Agent

Article XII

REMOVAL OF DIRECTORS

At a meeting of shareholders called expressly for that purpose, any one director. Or the entire board of directors, may be removed, with or without cause, by a vote of the holders of a majority of the shares then entitled to vote at an election of directors.

Article XIII

INFORMAL ACTION



Restrictions on the sale or transfer of the stock of this corporation may be set forth in a buy-sell agreement.


