**ARTICLE 5. Shares:** The corporation is authorized to issue 1000 shares of stock.

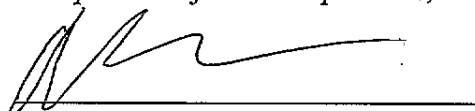

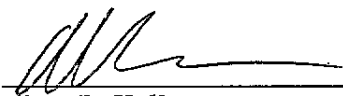
