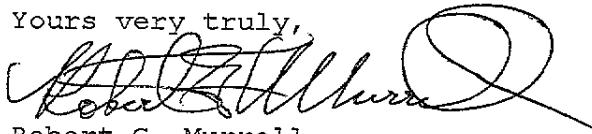

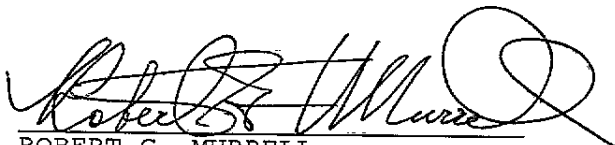

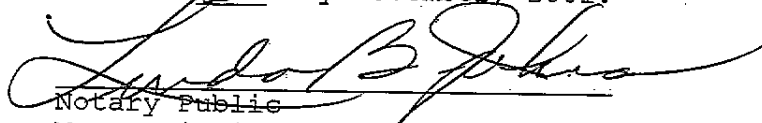

**ARTICLES OF INCORPORATION  
OF  
ROBERT G. MURRELL, P.A.**

**ARTICLE I  
NAME**

The name of this corporation is **ROBERT G. MURRELL, P.A.**

**ARTICLE II  
DURATION**

This corporation shall have perpetual existence commencing on the date of filing these Articles with the Department of State.

**ARTICLE III  
PURPOSE**

This corporation is organized for the purpose of transacting any or all-lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as it now exists or may hereafter be amended., and practice of law.

**ARTICLE IV  
CAPITAL STOCK**

This corporation is authorized to issue Seventy Five Hundred (7,500) shares of One Dollar (\$1.00) par value common stock, which shall be designated as the "Common Shares."

**ARTICLE V  
PREEMPTIVE RIGHTS**

**INDEMNIFICATION**

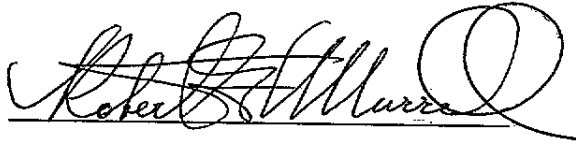
The corporation shall indemnify any officer, director or

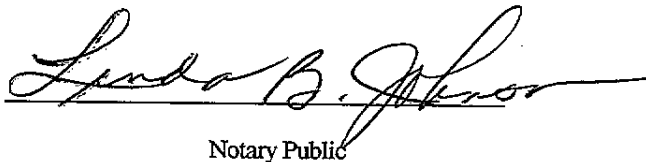

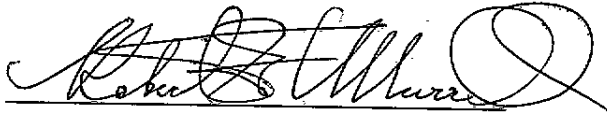

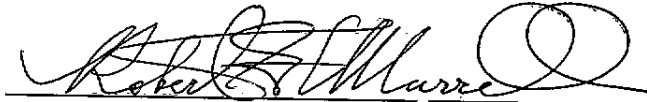
